Inmate Drug Testing

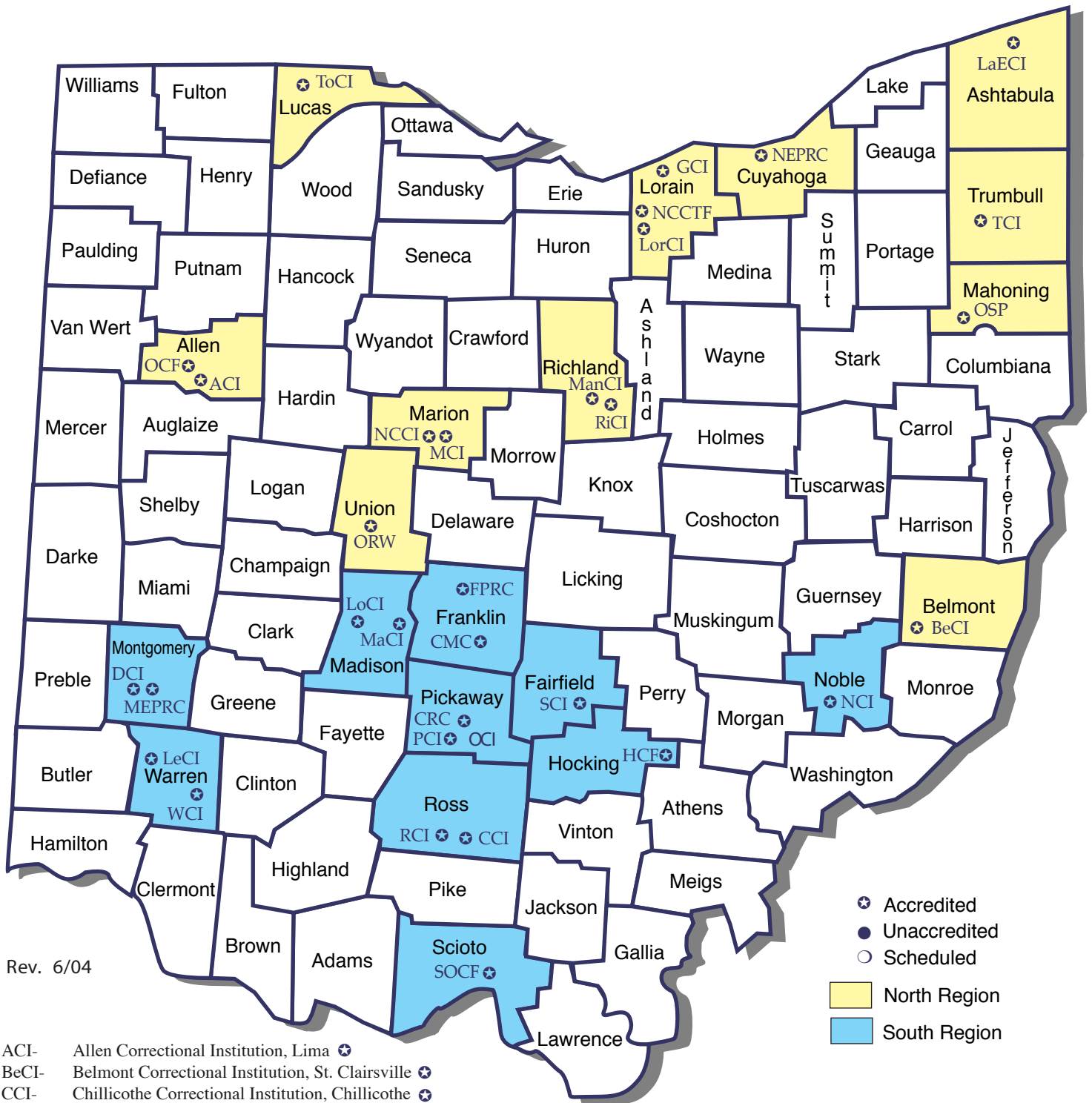
The Department does random drug testing on 5% of the inmate population each month.
