Re: Calendar Year 2011 Time Served Report

Please find attached a copy of the Calendar Year 2011 Time Served Report*. Assistant Bureau Chief Brian Martin helped to analyze the data and produce the report. The report presents data on the number of releases and average time served by legal mechanism of release, gender and offense type. The front summary page aggregates data on all prison exits excluding court releases. The report also includes separate tables on time served for all pre- and post-SB2 release types. The CY 2011 time served number are based on 19,684 non-judicial releases, representing a 7.85 percent decrease in these exits from 2010 (21,359) to 2011. The continued decline in the overall number of releases follows a reversal in new court commitments that began in 2007. Highlights from the report are summarized below:

1. The average time served in 2010 among all non-judicial releases was 2.10 years, representing a 3.5% (.07 year) increase from 2010. Historical patterns in time served averages are shown in the table above.
2. Parole releases accounted for only 150 of the 19,684 non-judicial releases, but their overall average time served increased from 2010 to 2011 (8.86 years served before released in 2010, 11.80 years served before released in 2011).
3. Releases onto PRC climbed from 6,688 in 2010 to 7,510 in 2011, an increase of 822 or 12.3%, representing 38.2% of all Senate Bill Two non-judicial releases. (an increase from 31.4% in 2010); correspondingly, EST releases were at 60.2%.
4. The following table summarizes average time served for all offenses and all releases sorted by sex and felony level.

Footnotes:

* The report was slightly modified beginning with the 2009 Time Served Report. The category "Life-Maximum Sentence" now includes those offenders who were convicted of rape/felonious sexual penetration and who received life as a maximum sentence. In previous reports these offenders were listed under the "Felony 1" category. This modification resulted in a slightly lower average time served in years for the Felony 1 category.
