* With the June 2014 report we changed slightly the way we collect and report institution population numbers. We wish to make the institution population reported in this report to match the number produced on the DOTS SNAP report on the first day of the month. We had been taking the population number for each prison from another DOTS report in each each prison sorted by race (a figure reported on pages 4 - 5). Since there is no DOTS report that does all we need, we are going to use the SNAPS as the basic and official total on page 3 of the monthly institution report. For the summary on pages 4-5, we will subtract the reported AWL numbers from the SNAPS total instead of the previous source. Feel free to check if you need further explanation.

** As a final note, our population total is 13 less than is reported as the total on SNAPS. The institution total population on SNAPS is 13 higher than if the individual totals are added. IT is working to correct this glitch.
