Re: Calendar Year 2010 Time Served Report

Please find attached a copy of the Calendar Year 2010 Time Served Report<sup>i</sup>. Assistant Bureau Chief Brian Martin helped to analyze the data and produce the report. The report presents data on the number of releases and average time served by legal mechanism of release, gender and offense type. The front summary page aggregates data on all prison exits excluding court releases. The report also includes separate tables on time served for all pre- and post-SB2 release types. The CY 2010 time served number are based on 21,359 non-judicial releases, representing a 8.48 percent decrease in these exits from 2009 (23,377) to 2010. The continued decline in the overall number of releases follows a reversal in new court commitments that began in 2007. Highlights from the report are summarized below:

- The average time served in 2010 among all non-judicial releases was 2.03 years, representing a 4.7% (.10 year) decrease from 2009. Historical patterns in time served averages are shown in the table above.
- The decrease is concentrated in average time served for Parole releases from 2010 to 2009 (9.86 years served before released in 2010, 10.22 years served before released in 2009), masking affects of increases among PRC and EST releases.
- Releases onto PRC declined from 8,774 in 2009 to 6,688 in 2010, a decrease of 2,086 or 23.8%.
- SB2 releases in 2010 represented the vast majority (97.4%) of all non-judicial releases, up slightly from 95.5% in 2009. PRC placements represented 31.4% of those releases (down from 37.6% in 2009); correspondingly, EST releases were at 66.1%.
- The following table is a new summary we have prepared. Some may find it useful for planning purposes. It is a summary of the first master table plus the judicial releases table.

i The report has been slightly modified. The category “Life-Maximum Sentence” now includes those offenders who were convicted of rape/felonious sexual penetration and who received life as a maximum sentence. In previous reports these offenders were listed under the “Felony 1” category. This modification resulted in a slightly lower average time served in years for the Felony 1 category.
