2007 = **1.68%**

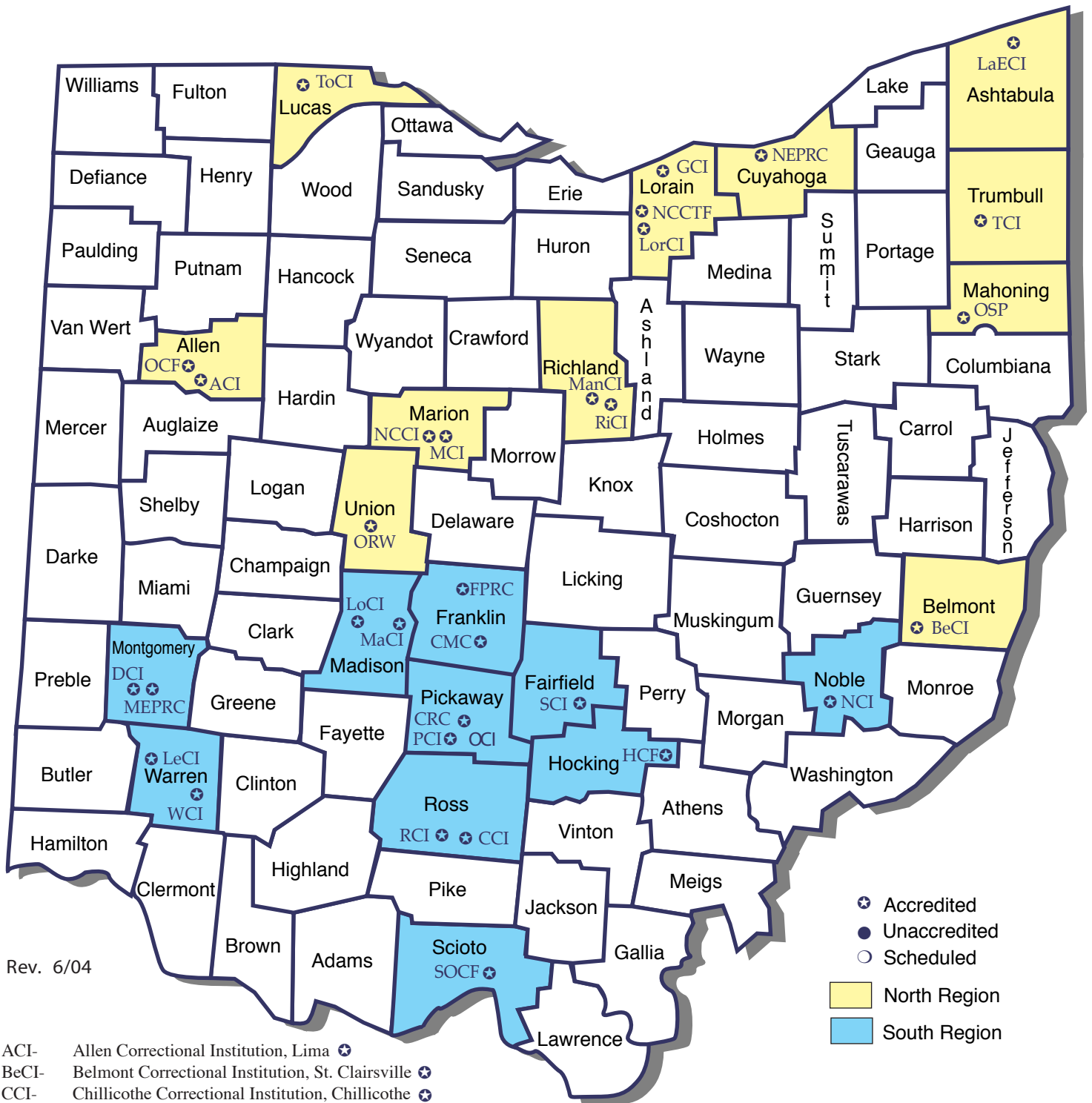
