Executive Summary

Ohio Community Correction Act (CCA) programs are non-residential sanctions that allow local courts to sanction certain offenders in the community saving scarce prison and jail beds for violent offenders. This program is a partnership between the State of Ohio and the Local Community Correction Planning Boards. Each Planning Board is comprised of local officials representing all areas of the criminal justice system within the county. Each CCA program is under the control of the Local Corrections Planning Board and administered by either the county or city officials. During Fiscal Year 2003, the CCA subsidy programs received a funding appropriation of \$ 22,515,678, to support programs in 77counties throughout Ohio.

CCA Prison Diversion Programs

In Fiscal Year 2003, Prison Diversion Programs received \$14,085,586 to support programs in 45 counties throughout Ohio.

- 9,032 offenders participated in CCA prison diversion programs:
 - \$1,560 annual average cost per offender
 - 13% convicted of 3rd degree felony
 - ♦ 27% convicted of 4th degree felony
 - ♦ 53% convicted of 5th degree felony
 - ♦ 79% Male
 - ♦ 52% White
 - ♦ 45% African American
 - Average age at admission 32 years old
 - ♦ 51% successful termination
 - Average length of stay 314 days

CCA Jail Diversion Programs

In Fiscal Year 2003, Jail Diversion Programs received 7,743,656 to support programs in 77 counties throughout Ohio.

- 21,036 offenders participated in CCA jail diversion programs:
 - ♦ \$368 annual average cost per offender
 - 5% convicted of 4th degree felony
 - 13% convicted of 5th degree felony
 - 77% convicted of misdemeanor crimes
 - 77% Male
 - ♦ 72% White
 - 24% African American
 - ♦ Average age at admission 32 years old
 - ♦ 76% successfully termination
 - Average length of stay 152 days

- Cuyahoga County Intensive Supervision Prison Diversion Program received the Clifford Skeen Award.
- Fremont Municipal Court Intensive Supervision Jail Diversion Program received the Clifford Skeen Award.
- Vince Polito, Chief Probation Officer for Cuyahoga County, received the Community Correction Act Professional Achievement Award.
- ♦ Jail and Prison Diversion Offenders performed over 361,673 hours of community service work within their respective communities.
- Offenders earned \$76,871,562; paid \$1,450,073 in restitution; \$4,980,356 in court costs; \$1,556,862 in child support.
- Over 18,141 offenders received drug and alcohol abuse counseling.


