Re: Calendar Year 2008 Time Served Report

Please find attached a copy of the Calendar Year 2008 Time Served Report*. Assistant Bureau Chief Brian Martin helped to analyze the data and produce the report. The report presents data on the number of releases and average time served by legal mechanism of release, gender and offense type. The front summary page aggregates data on all prison exits excluding court releases. The report also includes separate tables on time served for all pre- and post-SB2 release types. The CY 2008 time served numbers are based on 25,074 non-judicial releases, representing a 3.64 percent decrease in these exits from 2007 (26,021) to 2008. The decline in the overall number of releases follows a reversal in new court commitments that began in 2007. Highlights from the report are summarized below:

- The average time served in 2008 among all non-judicial releases was 2.11 years, representing a 3.4% (.07 year) increase since 2007*. This increase, while seemingly small, is the first since 2003, when a surge of parole releases under the Layne decision briefly interrupted an otherwise long term pattern in

declining time served averages dating to 1999. Historical patterns in time served averages are shown in the table above.

- The increase is concentrated most noticeably among PRC and EST releases (11.8% and 13.3% longer, respectively), and its broad-based pattern among almost all felony levels is indicative of longer sentences imposed under the Ohio Supreme Court's 2006 *Foster* ruling.
- Releases onto parole have also spent longer time in prison, though these increases are smaller (2.6%) and are rooted in a declining population of parole-eligible inmates increasingly concentrated among those serving life sentences.
- SB2 releases in 2008 represented the vast majority (94.6%) of all non-judicial releases, up slightly from 93.6% in 2007. PRC placements represented 41.6% of those releases (down from 42.7% in 2007); correspondingly, EST releases were 58.4%.
