Dear Sheriff Tharp,


The Bureau of Adult Detention received the plans of action and additional corrective material you submitted through the Ohio Jail Management System (OHJMS) in response to the annual inspection of the Lucas County Corrections Center on November 25, 2019. We appreciate your efforts in attempting to maintain compliance with the Standards for Jails in Ohio.

I have reviewed the provided material. The documentation will increase the level of compliance for the Lucas County Corrections Center. The jail is now compliant with Jail Standards: 5120: 1-8-01(A)(12)(Important); -02(B)(4)(Important); -04(K)(Essential); and -10(B)(Essential).


The facility remains out of compliance with Jail Standards: 5120: 1-8-01(A)(9)(Important); -02(D)(Important); -03(A)(1)(Essential); -03(A)(3)(Essential); -03(A)(6)(Essential); -04(A)(4)(Important); -04(J)(Important); and -10(F)(Essential). Plans of action submitted for these remaining deficiencies appear to identify the proposed means for meeting compliance with the standards. The Lucas County Corrections Center will remain a *Status Jail* until the next inspection or until the remaining corrective action has been completed.
