
Dear Sheriff Black,

The Bureau of Adult Detention has received the corrective material you submitted through the Ohio Jail Management System in response to the annual inspection of the Monroe County Jail on July 22<sup>nd</sup>, 2019. We appreciate your efforts in attempting to maintain compliance with the Standards for Jails in Ohio.

I have reviewed the provided material. The documentation will increase the level of compliance for the Monroe County Jail on specific standards reviewed this year. The jail is now in compliance with (Essential) Jail Standard 5120: 1-8-09(C) and (Important) standards 5120:1-8-02(B)(2); -04(A)(4); -04(B); -18(D); -18(E). The facility remains out of compliance with Important Jail Standards: 5120: 1-8-18(A)(1,2); -18(C)(3). The Monroe County Jail is now compliant with 100% of the Essential Standards and at least 90% of the Important Standards, meeting the requirements of a “**Compliant Jail**”.

Your continuing effort to maintain compliance with the Standards for Jails in Ohio is to be commended. The Bureau encourages the jail to correct the remaining deficiency noted in the inspection report prior to the next jail inspection. Congratulations and thank you for your cooperation in the 2019 annual inspection process.
