COVID-19 Inmate Quarantine and Isolation | **Quarantine** separates and restricts the movement of people who were exposed, or potentially exposed, to a contagious disease to see if they become sick. **Isolation** separates sick people with a contagious disease from people who are not sick.

Quarantined facilities are operating under modified movement and the populations are being separated by unit along with other precautionary measures. Every inmate at these facilities is monitored daily and has their temperature taken along with a check for symptoms. Overall testing increases are partially attributed to implementation of mass testing at designated facilities beginning 04/11/2020.
