## AUDIT FINDINGS

### **Narrative:**

During the pre-audit I reviewed every standard and compared those to the policies. I found that the policy described what operational practices would be taken to comply with the standard. Everything I read complied with every standard. I went to the facility in 6-22-2017 and conducted a briefing with leadership on what my audit would include. I then toured the entire facility inside and out. I went in every stairwell and looked in every closet. I observed PREA signs in all areas. The notice of my upcoming audit was posted in all units. On the last audit I suggested that windows be installed in all closets and doors without windows except bathroom areas. I also recommended that lighting be placed in all areas that would always remain on. Both of these recommendations were accomplished. I conducted 16 staff and 18 resident interviews. I spoke with several residents who stated they knew and understood PREA and they knew how to report any incident. I spoke with staff who also understood their responsibility with PREA allegations. I selected random residents to interview. Without exception they all knew about PREA, they knew how to report and verified the training upon entering the facility, they remember being questioned during the screening process and the 30 follow up. They also knew of the several ways to report any incident. I then interviewed 16 staff almost everyone on duty both the 22 and 23rd. Every staff member understood first responder duties. They also knew the ways to that residents could report any incident. I interviewed specialized staff that were responsible for the operational duties of training, screening, housing, investigating complaints, and follow up care and after action reports. I then reviewed random training files, resident files, and employee files. All documents verified the information I obtained from the observations and interviews. I then went home and went through all of the interviews, file reviews, observations and wrote the report.

## AUDIT FINDINGS

### **Facility Characteristics:**

The facility has 4 pods, 3 for males and 1 for females. Cameras were placed in areas to get the best view. The Residents are kept separate so they are able to separate based on risk. They have 220 resident beds with the current population of 194. They employ 106 full time or part time staff. Each pod had their own programming areas. The facility has one kitchen that facilitates all feeding. They have outside rec areas for every pod. They also have an area for intake of residents, main control, entrance, and admin areas. Residents are sent to the facility to go through programs and work release. Their stay is less than one year. The staff at the facility were open, friendly and helpful. The leadership is knowledgeable and very experienced. They all believe that their goal is to help residents be successful upon completion of the program. The facility has done a superior job in implementing all the PREA standards. They take their role very seriously and it shows in the open interaction with the residents. They have several staff that have been there for a long length of time which helps in consistency. I want to thank everyone at the facility especially the management team and PREA Coordinator for their hard work and dedication.

	<b>Auditor Overall Determination:</b> Exceeds Standard
	<b>Auditor Discussion</b>
	All areas of this standard were implemented three years ago and followed up on a regular basis. The PREA coordinator submits monthly reports to the Ohio Department of Correction, meets quarterly with other PREA coordinators of all Community Confinement Centers in the state of Ohio. It was very obvious that staff were well trained and prepared for any PREA issues that may arise.

<b>115.213</b>	<b>Supervision and monitoring</b>
	<b>Auditor Overall Determination:</b> Exceeds Standard
	<b>Auditor Discussion</b>
	The video monitoring is excellent. You can see clearly and observe all activities of staff and residents. I toured all areas of the facility and observed the staffing and camera locations. The staffing plan is reviewed yearly and after any incident. They installed windows in all the doors and lighting to insure residents and staff safety. They implemented all of the recommendation from their first audit. They also insure that in areas that cannot be viewed by staff or cameras that two staff are present when meeting with residents.

	<b>Auditor Discussion</b>
	All staff are trained in conducting searches of residents. I reviewed training records to assure compliance. Staff always announce their presence when entering an opposite gender unit. This was confirmed during interviews with 13 staff and 18 residents. All residents and staff interviewed understood the policies on cross gender searches, searching transgender residents and announcing themselves upon entering a opposite gender housing unit.

	<b>Auditor Discussion</b>
	Resident interpreters are never used. The facility uses an outside service for interpreter services. They also have several methods for residents with disabilities to understand the PREA policies. All residents and staff interviewed verified these practices. Signs are posted throughout the facility outlining how to report abuse.

	<b>Auditor Discussion</b>
	I verified through a file review of applications and background checks that all requirements of this standard were met.

	<b>Auditor Overall Determination:</b> Exceeds Standard
	<b>Auditor Discussion</b>
	The facility implemented all recommendations from the last audit. They installed windows in doors and lighting in areas to insure staff could see into all offices when making rounds. The camera system is excellent.

<b>115.221</b>	<b>Evidence protocol and forensic medical examinations</b>
	<b>Auditor Overall Determination:</b> Meets Standard
	<b>Auditor Discussion</b>
	The facility has a MOU for outside services to provide victim advocacy and provide support as needed. They only had one case and the resident declined to use the service. There are signs posted though out the facility identifying the service and the number and address of the service.

	<b>Auditor Discussion</b>
	The facility had 11 PREA complaints and only 1 needed a referral to law enforcement who declined to prosecute. All other were basically harassment issues and most were not substantiated. All policy and standards were followed. The facility has an MOU with law enforcement outlining responsibilities.

<b>115.231</b>	<b>Employee training</b>
	<b>Auditor Overall Determination:</b> Exceeds Standard
	<b>Auditor Discussion</b>
	All staff are trained in pre-service training and then annually. The training includes the zero tolerance policy for sexual abuse and harassment. How to fulfill the responsibilities for prevention, detection, reporting, and responding. The right to be free from retaliation. The dynamics of sexual abuse and sexual harassment. The common reactions of sexual abuse and how to detect the signs. How to communicate with gender non conforming residents. How to comply with the laws. All staff state they have taken the training and the signed training sheets verified attendance. During staff interviews staff stated they understand the PREA requirements and stated "its just the way we do business". I reviewed training files and conducted interviews to insure compliance.

	<b>Auditor Discussion</b>
	All contractors and volunteers received training and all documentation was reviewed.

<b>115.233</b>	<b>Resident education</b>
	<b>Auditor Overall Determination:</b> Exceeds Standard
	<b>Auditor Discussion</b>
	Within 48 hours of arrival the residents are given training on the zero tolerance policy. The training includes what is prohibited. How to report, their rights to be free from sexual harassment and abuse and policy for the prohibitions against retaliation. All residents sign a statement indicating they understand the policy. I reviewed resident files and the documentation was present in all random files selected. During the interviews all residents stated that they understood the policy and requirements. All residents interviewed stated they were given information on PREA upon arrival at the facility. Then within 48 hours they were given the training by resident trainers. Most residents joked they have been through training so often that they could give the training. There are posters all over the facility outline the zero tolerance policy and how to report. The facility also trains the resident visitors about PREA and what they should do if they receive any PREA related communication. I interviewed one resident trainer and he stated he always gives the training as he was trained and conduct the training in the presence of staff.

	The staff who conducts administrative investigations and taken the training conducted by NIC

	<b>Auditor Discussion</b>
	All training was completed as noted in training files and interviews.

<b>115.241</b>	<b>Screening for risk of victimization and abusiveness</b>

	<b>Auditor Discussion</b>
	The facility screens all residents prior to giving an housing assignment. Then the resident is rescreened within 30 days. I reviewed random files and interviewed residents and staff who verified the use of the screening instrument. The screening tool uses the questions raised in the standard to determine risk. I also reviewed a confidential resident roster that indicated those residents who were at risk or were a risk. The RS3's keep this documented up to date and they are the only ones who can make moves.

<b>115.242</b>	<b>Use of screening information</b>
	<b>Auditor Overall Determination:</b> Meets Standard
	<b>Auditor Discussion</b>
	The facility uses the screening information for decisions on housing, bed, work, education and program placement. With the design of the facility they are able to separate those residents who need to be kept separate. All residents stated they feel very safe at the facility. The facility has a policy on LGBTI residents and will work with each resident as an individual on any needs they may have and make accommodations. The resident's opinion will be given consideration. All residents can shower separately. All staff who is responsible for conducting these reviews understand the screening process and the responsibilities of placement of at risk residents.

<b>115.251</b>	<b>Resident reporting</b>
	<b>Auditor Overall Determination:</b> Exceeds Standard
	<b>Auditor Discussion</b>
	There are PREA reporting posters in all areas of the facility. Residents and staff have separate confidential locked boxes that are for reporting of PREA related incidents. There is a toll free number for staff and residents to report PREA related incidents. The facility trains all resident visitors on different ways they can report any incidents. All staff and residents are trained in the many ways of reporting. During the interview of 16 staff and 18 residents they verified that the training took place and named the many ways to report. I reviewed staff training files and resident files to review the records of training. Most of the residents stated they would report to the PREA coordinator.

<b>115.252</b>	<b>Exhaustion of administrative remedies</b>
	<b>Auditor Overall Determination:</b> Meets Standard
	<b>Auditor Discussion</b>
	There have been no grievances filed related to PREA incidents. Policy does outline responsibilities of staff and follows the standards.

<b>115.253</b>	<b>Resident access to outside confidential support services</b>
	<b>Auditor Overall Determination:</b> Meets Standard
	<b>Auditor Discussion</b>
	During the tour of the facility I saw the signs that stated the victim services toll free phone number. During the staff and residents interviews all knew that victim services were available. There was only one incident that required the offering of this service and the resident turned down the service.

<b>115.254</b>	<b>Third party reporting</b>
	<b>Auditor Overall Determination:</b> Meets Standard
	<b>Auditor Discussion</b>
	the facility trains visitors in the procedures to report PREA incidents. All staff and residents are trained in these procedures as indicated by training records and interviews with staff and residents. The facility maintains an MOU for victim services.

<b>115.261</b>	<b>Staff and agency reporting duties</b>
	<b>Auditor Overall Determination:</b> Meets Standard
	<b>Auditor Discussion</b>
	Policy dictates a duty to report immediately. 13 staff including 1 nurse all stated during the interview that they have a duty to report immediately any knowledge of sexual abuse or harassment. Training includes these procedures.

<b>115.262</b>	<b>Agency protection duties</b>
	<b>Auditor Overall Determination:</b> Meets Standard
	<b>Auditor Discussion</b>
	The facility policy and training dictate that immediate action is required if a resident may be in danger of harm. All staff interviewed stated that they would immediately remove the resident from the area or remove the suspected abuser.

<b>115.263</b>	<b>Reporting to other confinement facilities</b>
	<b>Auditor Overall Determination:</b> Meets Standard
	<b>Auditor Discussion</b>
	There was one situation that required the facility head to notify another facility of information of suspected abuse and a letter was written and policy was followed.

<b>115.264</b>	<b>Staff first responder duties</b>
	<b>Auditor Overall Determination:</b> Meets Standard
	<b>Auditor Discussion</b>
	All staff are trained in the first responder duties. During the interviews staff described in detail the procedures of securing the area, separating the resident victim and abuser, the collection of evidence, notifications of supervisors and law enforcement. Training included first responder duties.

	<b>Auditor Discussion</b>
	I have reviewed the coordinating response plans and the training records of staff to insure policy and standards were met. All 16 staff interviewed knew the coordinated response. The investigators and PREA coordinator work together when an incident occurs. I reviewed all reported incidents. This is evidence of compliance.

	There is no collective bargaining.

	<b>Auditor Discussion</b>
	The supervisors and PREA coordinator monitor the threat of retaliation. All of the supervisors stated they will monitor the threat of relation as long as required and would take firm action upon knowledge of any actions.

	<b>Auditor Discussion</b>
	The facility only conducts administrative investigation and law enforcement conducts criminal investigations. All investigators in the facility have taken the investigative training through NIC. The facility cooperates with law enforcement. I reviewed all investigations and all were handled according to policy and standards. I interviewed the investigators and they were aware of the responsibilities.

	Policy dictates a preponderance of evidence in administrative investigations. The investigative reports indicate that this is used in determining guilt.

	<b>Auditor Discussion</b>
	After reviewing the policy and the after action reports and the interviews I determined that all requirements were met. The paperwork indicates that notifications were made and staff followed up with staff and residents on the results and actions that were taken.

	The facility takes firm decisive action against staff who have sexually abused or harassed residents.

	<b>Auditor Discussion</b>
	Policy clearly outlines the procedures for disciplinary action for residents. It follows all of the standards. I reviewed all disciplinary actions and find the facility was in compliance.

	<b>Auditor Discussion</b>
	Residents will receive immediate medical and mental health services if they become a victim of sexual abuse. They will receive information on emergency contraception and sexually transmitted infections. All services are provided at no cost. All services are completed at the local hospital.

	<b>Auditor Discussion</b>
	The facility has a MOU that offers mental services free of charge to the resident. The facility also has trained councilors to treat residents. The local hospital with provide tests for sexually transmitted infections. All times lines are outlined in policy.

	<b>Auditor Discussion</b>
	I reviewed all of the after action reports. I also interviewed the Program Director, the Director of Operation and the Executive Director. All of those interviewed are involved in the review of all incidents. The completed reports indicate the team looks at need to change policy, whether the incident or allegation was motivated by race; ethnicity; gender identity; lesbian, gay, bisexual, transgender, or intersex identification, status, or perceived status; gang affiliation; or other group dynamics at the facility, examines the area in the facility where the incident allegedly occurred to assess whether physical barriers in the area may enable abuse, assess the adequacy of staffing levels in that area during different shifts, assess whether monitoring technology should be deployed or augmented to supplement supervision by staff, and prepares a report of its findings, including but not necessarily limited to determinations made and any recommendations for improvement and submit such report to the facility head and PREA compliance manager.

	All reports were done, but no report was ever requested by the justice department.

	The facility does quarterly reports to the state of Ohio, they meet quarterly to discuss findings and make recommendations. The do yearly reports and post to their web site.
